As part of our commitment to ensuring a safe training environment for all club members and site staff during the unprecedented, fast changing COVID-19 pandemic crisis, we need to ask you to confirm in writing by completing and signing below, that:

- You have no cause to believe that you have, or may have been exposed to COVID-19 (an NHS symptom checker can be found at <https://111.nhs.uk/covid-19>).
- You have been meeting the Government COVID-19 social distancing guidelines when not at work (as defined at <https://www.gov.uk/government/publications/staying-alert-and-safe-social-distancing>).
- As far as you are aware, you have not been in close contact with a confirmed case of COVID-19, or anyone who is showing symptoms consistent with COVID-19 within the last 14-days.
- You have not travelled to, and to your knowledge had no close contact with any individual travelling from any high COVID-19 risk countries (as deemed by UK Foreign & Commonwealth Office) in the 14-days prior to attending site (<https://www.gov.uk/guidance/travel-advice-novel-coronavirus>).
- You have not had a new persistent cough, loss of taste and/or smell, or a temperature of 38 degrees centigrade or above in the last 14-days.
- If you develop a new persistent cough, loss of taste and/or smell, or a temperature of 38 degrees centigrade or above at any point before or during or within 14-days following site attendance you will immediately inform the Club Welfare Officer (Birgit Van Meijgaarden).
- If you are contacted by NHS Track & Trace within 14-days of attending the pool session you will notify the club Welfare Officer (Birgit Van Meijgaarden).
- If you are over 70 years of age or have any pre-existing condition which would put yourself at increased risk of severe illness from COVID-19, as defined by the Government, you must inform the Club Welfare Officer (Birgit Van Meijgaarden) prior to attending or partaking in any diving activities.
- You will notify the Club Welfare Officer (Birgit Van Meijgaarden) immediately should anything change in regard to the above confirmations.
- You have read and understood the related document “Basildon Sub Aqua Club COVID-19 Safe Operating Practise for Pool Sessions”, and will comply.
